This period begins:

1 - From the date of registration of the base document with the AMF for an initial public offering and a capital increase.  
2 - From the date of filing of the draft offer with the AMF for public offers (OPA, OPE, etc.)

- 3.The space sold under an OPCVM contract is reserved for OPCVM communication.
- 4.The publication of a minimum of 2 financial notices over 12 months from the date of subscription to the contract.
